Material Compliance

Manufacturing companies must be able to guarantee the material compliance of their products with legal and customer requirements. Failure to comply with material specifications not only means product liability risks but also potential damage to the image and loss of market. Getting around this calls for detailed knowledge of the ingredients and composition of the substances, materials and products used.

Material compliance applicability and risk analyses


